Rates for Accommodation in Hotels for Inter State Passengers

Addendum -2 Dated 11.05.2020 on the Subject of SOP FOR

ENTRY OF Persons from Other States to Karnataka.

In the aforementioned Order in the reference cited above, Commissioner, Health & Family Welfare Services, has modified Para 5.5 of the SOP Version 2.

Para 5.5 Reads as follows:-

"5.5 The Category-II returnees should be quarantined as follows:

- I. All persons travelling to Karnataka from any other State and found asymptomatic on arrival shall be quarantined compulsorily in institutions (school/hostels/hotels (paid basis)/Kalyan Mantapas etc. for a period of 14 days in Urban as well as Rural Areas.
- III. Deputy Commissioner/ Special Commissioner, BBMP will fix the rates for hotels where such returnees will be staying on payment basis.

Accommodation in Hotels would be on self-payment basis by the Inter State Passenger as per the aforementioned Order.

Matter was discussed in detail with Deputy Commissioner, Bengaluru Urban in terms of availability of Hotels, prevailing rates and rates decided earlier for Hotels in the context of Asymptomatic International Passengers and accordingly the following rates are hereby fixed:-

1. Budget Hotels:

- Rs 1200 Per Person/ Day Inclusive of all Taxes and Breakfast, Lunch & Dinner.
- Rs 1400 for Twin Occupancy/Day inclusive of all Taxes and Breakfast, Lunch & Dinner.

2. Low Budget Hotels:

- a. Rs 750 Per Person/Day inclusive of all Taxes and Breakfast, Lunch & Dinner.
- b. Rs 900 for Twin Occupancy/Day inclusive of all Taxes and Breakfast, Lunch & Dinner.

Classification of Hotels into Budget and Low Budget Hotels would be based on the submission of the Property Owner/ Hotelier on the Category he wishes to consider for his Property and no choice would be available to the Property Owner to change his Category in future from Low Budget to Budget Category.

Property Owners/ Hoteliers must inform Office of Deputy Commissioner, Bengaluru Urban on the Location of the Property, Number of Rooms Available and Category among the above 2 Options (Budget/Low Budget) in which he wishes to get his Property registered for accommodating Inter State Passengers.

Paying Guest Houses will be treated on par with Low Budget Hotels.

As far as the accommodation in Star Category Hotels is concerned, as decided for International Passengers the Rates for Inter State Passengers will be similar and as follows:-

- 1. Rs.3000 Per Person /Day inclusive of all Taxes and Breakfast for 5 Star Hotels (Rs.550 for Lunch & Rs.550 for Dinner would be charged in addition).
- 2. Rs.3700 for Twin Occupancy inclusive of all Taxes and Breakfast for 5 Star Hotels (Rs.550 for Lunch & Rs.550 for Dinner Per Person would be charged in addition).
- 3. Rs.1500 Per Person /Day inclusive of all Taxes and Breakfast for 3/4 Star Hotels (Rs.175 for Lunch & Rs.175 for Dinner would be charged in addition).
- 4. Rs.1750 for Twin Occupancy inclusive of all Taxes and Breakfast for 3/4 Star Hotels (Rs.175 for Lunch & Rs 175 for Dinner Per Person would be charged in addition).

Star Hotels would be made available by DC Bengaluru Urban on the basis of availability of rooms for the same and mere fixation of rates cannot be taken as criteria on the certainty on availability of Star Category Hotels.
