CIRCULAR

Sub: Operating of Industries / Industrial Establishments in

Bengaluru Urban & Rural Districts- Reg

Ref: 1) Order No. RD 158 TNR 2020, dated 13.07.2020.

- 2) Letter No. CI 06 SPI 2020, dated 24.03.2020.
- 3) Circular No. CI 06 SPI 2020, dated 01.04.2020.
- 4) Circular No. CI 06 SPI 2020, dated 03.04.2020.
- 5) Order No. RD 158 TNR 2020, dated 09.05.2020.

The Government in its Order cited at ref (1) above, ordered lockdown of Bengaluru area comprising of BBMP area, Bengaluru Urban District and Bengaluru Rural District to combat the spread of COVID-19 for a period of 7 days w.e.f., 8 pm on 14.07.2020 to 5 am on 22.07.2020.

However, Industries / Industrial Establishments (both Government & Private) as listed below are allowed to operate (outside containment):

- a. Production units which require continuous process, and their supply chain.
- b. Food processing industries, manufacturing of essential goods, including drugs, pharmaceuticals, medical devices, medical oxygen, their raw material and intermediates.
- c. Manufacturing of packing materials.
- d. Manufacturing and other industrial establishment with access control in Special Economic Zones (SEZs) or outside municipal limits and Export Oriented Units (EoUs), Industrial townships adhering to National Directives for COVID-19 management.
- e. Animal feed manufacturing and feed plants including supply of raw material such as maize and soya.
- f. Milk products and milk processing plants.
- g. Hatcheries and poultry feed plants.
- h. Manufacturing of fertilizers, pesticides and seeds.

As mentioned above, manufacturing of essential goods and production units which require continuous process & their supply chain are allowed to operate during lockdown.

Many essential goods industries and continuous process industries are requesting the State Government to clarify on the list of essential goods and continuous operating industries to be operated during lockdown.

Also, many industries operating in Ramanagar, Kolar, Chikkaballapur and Tumakur Districts are seeking clarification regarding movement of people & transportation from Bengaluru area since many employees / workers working in their industries are commuting from Bengaluru.

Further, industries operating in industrial areas / estates are seeking clarification regarding operation of their industries as Industrial Township is allowed in the Government Order cited at ref (1) above.

The Government in its Letter / Circular dated 24.03.2020 and 01.04.2020 cited at ref (2) & (3) above, has notified the list of essential industries and notified the continuous process industries vide Circular dated 03.04.2020 cited at ref (4) above.

Bengaluru Urban, Rural, Ramanagar, Kolar, Chikkaballapur and Tumakur Districts are considered as one unit for movement & transportation of people vide Order cited at ref (5) above.

The Chief Secretary has conducted Video Conference with all concerned Secretaries, BBMP and Police Commissioner, Bengaluru regarding implementation of lockdown order dated 13.07.2020 and he has advised the Commerce & Industries Department to issue clarification / guidelines with respect to operating of industries during lockdown.

In view of the above, Industries and Industrial Establishments which are eligible to operate as mentioned above, will continue the operations subject to adhering to the Standard Operating Procedure (SOP) as defined by Ministry of Home Affairs, GoI from time to time and as per the guidelines issued by State Government Order No. RD 158 TNR 2020, dated 13.07,2020.

Further, the following clarification is issued for operation of industries during lockdown:

- List of essential industries and continuous process industries are enclosed as **Annexure** to this Circular.
- ➤ Industries in industrial areas / estates of Bengaluru Urban and Rural Districts are allowed to operate as in Industrial Township.

- ➤ Bengaluru Urban, Rural, Ramanagar, Kolar, Chikkaballapur and Tumakur Districts are considered as one unit for movement & transportation of people from Bengaluru and vice-versa.
- ➤ Employees/workers working in these industries are allowed to travel with valid ID Card issued by their industry to the place of work and back.
