CIRCULAR

Sub: Supply of additional Ventilators to Taluka Level Hospitals (TLH)

During establishment of 3 bed ICU at Taluka Level Hospitals during FY 2016-17, 1 ventilator was provided.

After receipt of ventilators from Government of India for COVID-19, additional 2 ventilators have been provided during July and August 2020.

In view of the surge in COVID cases, it is now decided to provide 3 more ventilators to each Taluka Level Hospital (Annex. Enclosed)

Separate enclosure is already available for the existing 3 bed ICU and ventilators. The Administrative head is hereby ordered to utilize fund available under Aarogya Raksha Samithi (ARS) or National Free Diagnostic Scheme (NFDS) and ensure a separate enclosure is provided for the additional 3 ventilators being provided now. This is to ensure all 6 ventilators are installed and used for management of COVID patients.

The District Drug ware house Pharmacist shall ensure ventilators available at District Drug ware house are shifted to Taluka Level Hospitals, facilitate installation of the ventilators by co-ordinating with
